- 2. Erika Endrijonas Co-Facilitator Report
  - a. A caucus logo was created by Erik Fallis.
  - b. Pasadena College is raising the transgender flag tomorrow, Saturday is Transgender Day. All were encouraged to provide awareness at their respective institutions.
  - c. 4th annual CCC LGBTQ summit coming up May 4-5 (Virtual), invitation will be going out to all of those who participated in todays meeting.
  - d. LGBTQ Leaders in Higher Education (formerly LGBTQ Presidents group)
    - i. This is a national organization.
    - ii. Working on institute; tentatively scheduled for June 15th-17th at Pasadena City College.

  - f. Have around 25 attending regular
  - g. Bylaws sent out, 14 responses, all positive, so calling it good
  - h. Need to get leadership in place, and sent out multiple emails, people were nominated. Five positions, CEO or Trustee, and then at large positions don't specify those roles, so open to other positions.
    - i. E.g., both Erik Fallis and Brian Lofman could serve in an at large role given their expressed interest and positions.

- Proposed that the next meeting take place in spring, but perhaps not at the Trustees Conference. Many believe the caucus is associated with the conferences, so membership/participation would likely expand if it was clear that there wasn't an affiliation with the conference.

  - g. Elliot Stern a legislative advocate, would be willing to serve as a liaison.
